The Quonset Water Department is offering rebates to our water customers who purchase and install a new, qualifying high-efficiency Toilet, Urinal and or Flush Valves.

Save Water, Save Money!

This rebate program is for replacement fixtures only. This rebate program has been extended for a second year, October 1, 2009 and continuing through September 30, 2010. We cannot guarantee any rebate beyond the September 30, 2010 date.

Qualifying High Efficiency water saving devices under this rebate program must be one or more of the items below:

- Toilet Fixture (tank type) with a maximum rated flushing capacity of 1.3 gpf (gallon per flush), 4.8 lpf (liters per flush).
- Toilet Flush Valves (tankless) with a maximum rated flushing capacity of 1.3 gpf , 4.8 lpf.
- Toilet Duel Flush Valves (tankless) with a maximum rated flushing capacity of 0.8 gpf, 3.0 lpf liquid and 1.6 gpf, 6.0 lpf solids.
- Urinal Flush Valves (tankless) with a maximum rated flushing capacity of 0.5 gpf, 2.0 lpf.

To be eligible for the rebate, you need to just purchase new, high efficiency replacement fixture(s) and follow these steps:

- Purchase a new, high efficiency unit.
- Rebate is for reimbursement of 25% of the purchase price of the Fixtures. The maximum annual rebate shall not exceed \$3,000.
- The new, qualifying unit must be installed at a site with water provided by the Quonset Water Department and remain at the installation site for a minimum of 2 years after installation date.
- Submit your original sale receipts with a completed the attached application form.
- Sales receipts must include form of payment information (cash, check, or charge), purchaser name and installation address, purchase date, installation date, purchase price, brand, model number, and rated capacity.
- All rebate applications must be postmarked no later than 90 days after purchase date. Allow eight weeks for processing.
